WHEREAS: Tioga County has budgeted for replacement of the chiller at the Public Safety Building; and

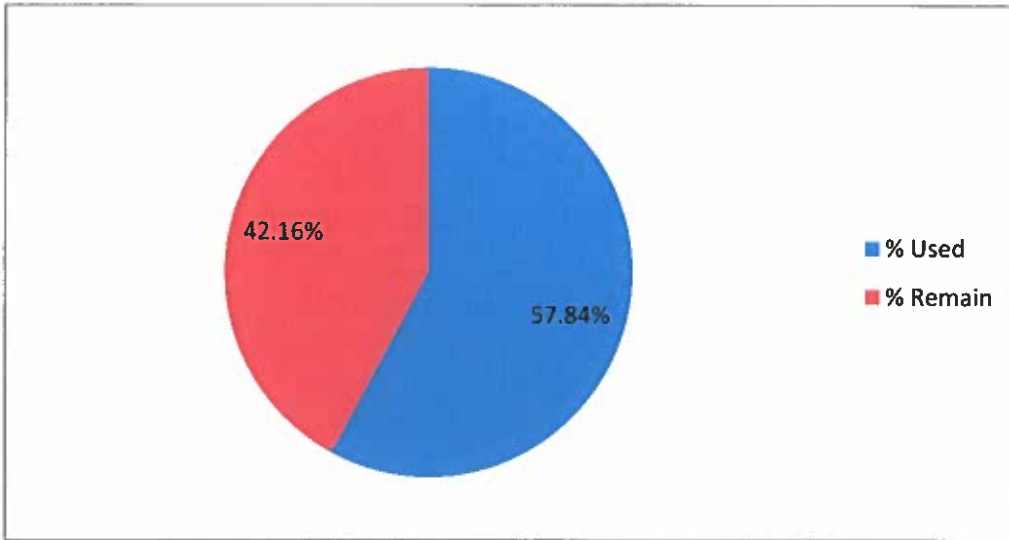
WHEREAS: The Commissioner of Public Works received a proposal for design services for this project from Delta Engineers, Endwell, NY; and
